Rail Baltica is the largest Baltic transport infrastructure project that will create the North – East economic corridor. It will be an electrified, speed railway line with modern high infrastructure for passenger and freight services, ensuring environmentally friendly and fast transportation from Tallinn the to Lithuanian-Polish border. Rail Baltica will connect the Baltic States with Central and Europe. The project is largely Western co-financed by the European Union. It has to be well-governed, with clear financial flows and procurement systems.

The three Baltic States' joint venture - **RB Rail AS**, was established in October 2014 and is registered in Latvia. The joint venture's shares are equally held by SIA Eiropas Dzelzceļa Līnijas in Latvia, UAB Rail Baltica Statyba in Lithuania and OU Rail Baltic Estonia in Estonia.

PURPOSE

Drafting of legal documents, representation of the company's interests at state and municipal authorities and private companies, taking responsibility for the protection of the company's legal and legitimate interests.

QUALIFICATION

- A professional Master's Degree in Law;
- At least 3 years' experience as a lawyer in the real estate and construction sector;
- Ability to use legal methods in solving legal issues and disputes;
- Be proficient in the institutional system of administrative and municipal authorities of Estonia, especially in regard to matters of spatial planning and construction;
- Knowledge of Estonian and international private law and commercial law in the fields of real estate and construction;
- Excellent understanding and knowledge of the EU and Estonian business law and their procedure, as well as standard documents applicable to the company's operations in the fields of real estate and construction (incl. FIDIC contracts);
- Knowledge of EU and Estonian laws and regulations. Knowledge of Latvian and Lithuanian laws and regulations will be considered as an advantage;
- Experience in drafting of legal documents and draft laws;
 - Ability to prepare, organise and perform actions to solve legal issues in material and procedural law;
- Fluent knowledge of the official language, knowledge of legal terminology and its use in the official language;
- Excellent knowledge of English and experience in the preparation of legal documents in English;

- To prepare replies to applications, complaints and suggestions submitted by private individuals and legal entities;
- To provide legal support in solving disagreements and disputes, including the preparation of documents for courts and, if necessary, to represent the company in court;
- To prepare a legal opinion/report on transactions, regulatory requirements, impact of laws, regulations and case-law, etc.;
- To follow amendments to the laws and regulations of Estonia and the EU and ensuring compliance thereto;
- To provide communication and information exchange between the company's employees and other stakeholders.
