2,	Do we understand correctly that the Special Excess Protection for Supervisors Board Members and Shareholders' Representative is an unconditional extension and cannot be restricted by market practice extension Special Excess Protection for Non-Executive Directors?	The Special Excess Protection for Supervisory Board members and Shareholder's representatives is an unconditional extension. This protection in the policies may be named as a Special Excess Protection for Non-Executive Directors (including, without limitation Supervisory Board members and Shareholder's representatives). For avoidance of misunderstandings, RB Rail AS would like to remind that in Latvia one of the options for engagement of Supervisory Board members are employment agreements, hence it is important for RB Rail AS that the cover also covers those situations when Supervisory Board members are hired on employment agreement basis (if such situation occurs).
