1	Ref to Clause 5. Subject-matter of the open competition. 5.10. The delivery of the Detailed Technical Design Review and Design Expertise Services will mostly take place in Lithuania. We understand that the services will be provided from Consultants home office ensuring the presence of the key experts in Lithuania for the relevant meetings. Please confirm.	Procurement commission hereby confirms that Service provider is not obliged to be located in Lithuania for the provision of the Design Review and Design Expertise services. Nevertheless, Service provider shall ensure the presence of experts during all meetings necessary for the provision of the services and in full extent envisaged in Technical specification, Regulation and Draft Contract of the open competition (meetings mostly will take place in Lithuania, at Contracting Authority's premises).
2.	Please confirm, that participation in Technical assessment of the detail technical Design for Rail Baltica in Lithuania (Kaunas-Ramygala section and Ramygala-LT/LV border section) will not affect (conflict of interest) participation in technical works supervision for construction of mentioned sections.	Procurement commission hereby confirms that participation in the Design Review and Design Expertise services in Lithuania will not be considered as restrictive for the Tenderer's participation in technical works supervision for construction of the design sections named.

Please clarify if the foreign (not Lithuanian) Key experts, proposed for technical assessment of the detail technical Design for Rail Baltica in Lithuania (Kaunas-Ramygala section and	Procurement commission hereby kindly explains that in order to participate in the open competition in case the Tenderer proposes foreign (not Lithuanian) Key experts, it is not mandatory for such experts to have Qualification Certificate issued by

Ramygala-LT/LV border section) should have a Qualification Certificate (TPD), issued by Lithuanian Certification Center (SPSC) for expertise services.


Nevertheless, in accordance with Clause 7.5.1. 1., 7.5.1. 2., 7.5.1. 3., 7.5.1. 4. of the open competition Regulations Key experts named in the above-mentioned Clauses shall have professional qualification/education according to the Country's (Country, where qualification/education has been obtained) legislation for the provision of respective services in the field of his/her expertise (if necessary, by the respective Country's legislation).

In accordance with Clause 6.2., 6.3. and 6.5. of the Technical Specification of open competition Regulations, for the provision of the Design Expertise Services, in case the Tenderer is awarded with the contract signing rights, the Tenderer shall follow requirements established in Technical Specification (Table No 5 "Key-Experts" and Table No 6 "Required non-exhaustive Additional Experts") and shall obtain professional competence (qualification) for experts proposed for the provision of the Design Expertise Services during the fulfilment of the contract, as required.

Procurement commission hereby kindly explains that in order to participate in the open competition (during the procurement stage) it is not mandatory for the foreign Tenderer (registered or residing outside Lithuania) to have Qualification Certificate issued by Lithuanian Construction Production Certification Center (SPSC).

Nevertheless, in accordance with requirements established in Clause 7.2.1. of the open competition Regulations, in order to participate in the open competition the Tenderer or all members of the partnership (if the Tenderer is a partnership), a person
