Please be aware that subject – matter of this competition isn't any construction works, but only supply of construction materials.</p> <p>2) Requirements set in sub-clause a) and b) under Clause 4.4.2. refers to experience gained in provision of supplies of construction materials not performance of construction works. Experience gained in provision of supplies according to requirements set in sub-clause a) and b) under Clause 4.4.2. shall be met during any of continuous 12 months period.</p>

Vai arī mēs paši sagatavojam LOI pēc mūsu parauga?</i>)</p>	<p>1) Yes, it is requested to specify all member of the partnership in Annex No 1_1 (Application form) of Regulation if the Candidate is a partnership, but Application may be signed only by one member of the partnership who is authorized to represent partnership.</p> <p>2) Yes, details of all members of the partnership may be specified in one Application form. There is no requirement to fill separate Application form for every member of the partnership.</p> <p>3) Unfortunately, Procurement Commission cannot provide unified template for letter of intent or possible content for this document. It is up to the Candidate to prepare letter of intent according to requirements specified in Clause 6.4.3. of Regulation. Please note that all information required by Application shall be submitted regarding each member of the partnership regardless of the form of the partnership.</p>
