Rail Baltica will connect the Baltic States with Central and Western Europe. The project is largely co-financed by the European Union. It must be well-governed, with clear financial flows and procurement systems. JOB PURPOSE

The primary responsibilities of Environmental Expert will be to serve in an expert role regarding environmental issues including planning, analysis and supervision of the design process of the Rail Baltica project to ensure innovative solutions and environmental compliance. Environmental Expert is part of the Technical Division and will report to Spatial Planning and Environmental Team Leader. Environmental Expert will follow the guidance of Lead Environmental Expert.

REQUIREMENTS

- Master's degree or equivalent in Environmental engineering or Civil Engineering;
- 3+ years' experience of Environmental Impact assessments, Environmental studies during design process; Client representative experience for 3 years desired;
- Knowledge of EU and national construction and environmental legal acts;
- Project management experience;
- Technical writing skills, and critical reviewing skills for analysis and development of technical reports on a conducted research;
- Well-developed verbal and written communication skills, with ability to effectively interact with project stakeholders, business partners, regulatory authorities and internal technical team members;
- Experience of the environmental impact assessment for noise evaluation in the railway infrastructure projects would be considered as an advantage;
- Fluent in English and Latvian, good command of technical English;

- Prepare, review, and update environmental investigation reports;
- Supervise work of third-party service providers;
- Prepare permit applications and agreements as needed by regulatory agencies;
- Obtain, maintain, modify and renew environmental permits and licenses;
- Provide technical support for environmental remediation projects and legal actions;
- Analyse scientific data and do quality-control checks;
- Monitor the progress of environmental improvement programs;
- Be updated on the latest development regarding environmental safety, new laws and related program areas;
