## Electronic Procurement System

**Answers to questions from the interested suppliers  
in the competitive procedure with negotiations  
“Consolidated supply of turnouts and rail expansion joints for Rail Baltica railway construction”,  
identification number RBR 2021/2**

RB Rail AS presents following answers to the questions received from the interested suppliers until 14 July 2021:

Nr.	Questions	Answers
1.	Do we need to fully register the 3 companies of the group and distinguish the application form, or do we have to register the 3 companies independently?	No, there is no necessity to register all partnership members at E-Tender system. Only one member of the partnership may be registered in E-Tender system who can submit Application on behalf of the partnership. And also it is requested to specify all members of the partnership in Annex No 1.1 (Application form) of Regulations if the Candidate is a partnership, but Application must be signed only by one member of the partnership who is authorized to represent partnership.
2.	For lot 2 where we hire 2 of our companies, which one must register?	If it is intended to submit the Application by group of suppliers, it is sufficient if only one supplier is registered in E-Tender system.  Additionally, if the Tenderer is relying on the capabilities of other entities to prove its compliance with any of the qualification requirements, it must identify all these entities by filling respective rows in the Application form (Annex No 1.2 of Regulation). In addition, the Tenderer shall indicate also what kind of capabilities the Tenderer is relying on (for instance previous experience etc.) to meet required qualification requirements. If the Tenderer intends to rely on the capabilities of other persons to meet

		any of the qualification requirements, <b>please refer also to Clause 4.4.5, 4.4.6 and 4.4.7 of Regulation.</b>
