DESCRIPTION OF THE AMENDMENTS:	 The Parties have entered into Agreement "Engineering services for preparation, procurement and supervision of Rail Baltica Control-Command and Signalling subsystem deployment" No 1.19/LV-2021-76 dated 18 January 2022 (hereinafter – Agreement). Based on the Clients request, the Consultant has submitted its proposal for additional services in respect of review and analysis report of CCS Concept design according to "Operational Brief" prepared by the Shadow operator (ID No CCS-SIE-RBR-2023-00028 dated 12 October 2023). The Parties have agreed to conclude the Variation in respect of Additional Services of review and analysis report of CCS Concept design according to "Operational Brief" prepared by the Shadow operator for the Phase 1 (Preparatory phase) in line with the Agreement requirements in the total amount of EUR 62 378,00 EUR without VAT. Taken into account that Additional services of review and analysis report of CCS Concept design according to "Operational Brief" prepared by the Shadow operator have impact on delivery of Service Package – 3 and Service Package – 6 within Phase 1 (Preparatory phase), the Parties agree to extend the milestones for Service Package – 3 and extend the deadline

	for Service Package – 6, thus stipulating that the milestones for Service Package – 3 are in accordance with Clause 4.1.5. of Appendix 1 [Scope of Services] as set in Annex 1 of this Agreement Amendment Notice and deadline for Service Package – 6 and Additional services is one (1) month from the date of signing the Agreement Amendment Notice No 3.
AMENDMENT OF THE	The Agreement shall be amended as follows:
AGREEMENT:	1. The Consultant shall provide to the Client additional services of review and analysis report of CCS Concept design according to "Operational Brief" prepared by the Shadow operator (hereinafter - the Additional Services) for the Phase 1 (Preparatory phase) in line with the Agreement requirements, Technical specification and the Consultant's Proposal.
	 The Parties agree that the total amount of Additional Services is EUR 62 378,00 (sixty-two thousand three hundred seventy-eight euros, 0 cents), (without VAT).
	3. The Parties agree that the Additional services have impact on delivery of Service Package – 3 and Service Package – 6 within Phase 1 (Preparatory phase), thus the Parties agree to extend the milestones for Service Package – 3 and extend the deadline for Service Package – 6 and set deadline for Additional services, stipulating that the milestones for Service Package – 3 are in accordance with Clause 4.1.5. of Appendix 1 [Scope of Services] as set in Annex 1 of this Agreement Amendment Notice and deadline for Service Package – 6 and Additional services is one (1) month from the date of mutually signed Agreement Amendment Notice No 3.
	4. The Sub-Clause 4.1.5. of Appendix 1 [Scope of Services] shall be introduced in a new wording as set forth in Annex 1 of this Agreement Amendment Notice.
	5. The Additional Services shall be provided as one - off services and paid after completion in accordance with the Sub-Clause 7.2.1. of Particular Conditions of the Agreement.
	6. As a result of the Additional Services, the Agreement Price for Preparatory phase (Phase 1 services) set in the Clause 10 a) of Form of Agreement and Appendix 3 [Renumeration and Payment] has been agreed to increase by EUR 62 378,00 and thus shall in aggregate be in the amount of EUR 1 761 115.18 (excluding VAT), thus the Clause 10 of Form of Agreement shall be amended and introduced in the new wording as set in Annex 1 of this Notice.
	7. The Consultant's Proposal for the Additional Services shall be attached to this Agreement Amendment Notice as Annex 2 thus becoming part of this Agreement Amendment Notice.
	8. Technical specification for Additional Services (Annex 3 to this Agreement Amendment Notice) shall be added as an annex to the Appendix 1 [Scope of Services], thus becoming part of the Appendix 1 [Scope of Services]. This document annexes the existing Appendix 1 [Scope of Services] and does not replace it. All provisions and requirements included in the Appendix 1 [Scope of Services] of the Agreement are applicable to the Additional Services and deliverables included in the Variation No.3, if not directly specified otherwise in this Technical specification for Variation No.3.

By signing this document, the Consultant irrevocably certifies and confirms that there are no claims or circumstances, caused due to this Agreement amendments notice (Variation No 3) that could cause any additional variations concerning extension of time for completion, compensation of costs, extra remuneration or exceptional costs, as provided in this Agreement Amendments notice and other provisions introduced by this Agreement Amendments notice and its appendices that are related to the subject-matter of this Amendment Agreement Notice.

Upon signing this Agreement Amendments notice Parties have fully resolved all aspects in respect to Variation requests with the reference: No CCS-SIE-RBR-2023-00021 dated 30 May 2023 "CCS Engineer Shadow Operator deliverables extra activities" superseded by No CCS-SIE-RBR-2023-00028 dated 12 October 2023 "CCS Engineer Shadow Operator deliverables extra activities_amendments".
