Belonging to the System Engineering and Assurance Department (SEA) in RB Rail AS, under the supervision of the System Engineering Team leader, and in coordination with the Requirements, Configuration, Interfaces, Design and Construction and RAMS Managers, the I&V&V Manager will be responsible for the definition, development, deployment, and coordination of the integration, verification, and validation activities within the RBGP. The position entails working at subsystems and system level, inside RB Rail but also setting proper interfaces and coordination with the external stakeholders (Implementing Bodies, design and build contractors, system suppliers, etc.).
